

**RESOLUTION NO. 2009-35**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCOA BEACH, FLORIDA, SITTING AS AN ELECTION CANVASSING BOARD TO CERTIFY THE RESULTS OF THE GENERAL ELECTION HELD ON NOVEMBER 3, 2009, FOR:

- FOR CANDIDATE SEAT NO. 2, AND
- CONFIRMING THAT THE CANDIDATE FOR SEAT NO.3, WAS UNOPPOSED AND RE-ELECTED.

**WHEREAS**, as of the Registration Book Closing for the November 3, 2009, General Election, there was a total of 8,808 Registered Voters in Cocoa Beach; and

**WHEREAS**, Commissioner Kevin Pruett, Seat 3, whose Commission term would have expired on November 2009, was unopposed and re-elected for a three-year term.

**WHEREAS**, the November 3, 2009, a General Election was held to elect a City Commissioner for Seat 2; and

**WHEREAS**, two candidates, Ken Griffin (incumbent) and Ben Malik qualified to run for City Commissioner Seat 2; and

**WHEREAS**, on November 3, 2009, out of 2134 votes cast, Ken Griffin received 1208 votes, and Ben Malik received 926 votes; and


**NOW, THEREFORE, BE IT RESOLVED** that with the approval of this Resolution, we do hereby declare that:

- Mr. Ken Griffin is elected as City Commissioner Seat No. 2 for a three-year term, and
- Kevin Pruett, City Commissioner Seat No. 3, is re-elected for a three-year term.

Upon Motion by Commissioner John and Seconded by Commissioner Williams, this Resolution is duly adopted at a Regular Meeting of the City Commission of the City of Cocoa Beach, Florida, held on the 5th. day of November, 2009.


